ASHRAE Proposes Changes

If you are a regular reader of this newsletter you know that the ASHRAE Standard 189.1 for High Performance Green Buildings is undertaking a reorganization to make the standard and the resulting International Green Construction Code (IGCC) more adoptable. As part of this work the Project Committee recently voted on a number of addenda to mark specific provisions of the standard as ones that might be suitable for a jurisdiction to exclude if they are trying to create a minimum green building code. These so-called "above-core" provisions are found in all of the substantive sections of the standard. 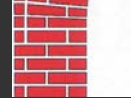
