LEED Revisions: Raising the Green Standard

If the U.S. Green Building Council's membership approves revisions to LEED guidelines next year, builders will start using it by June 2015. "The bar is getting raised, but that doesn't necessarily mean it's harder to meet because of the way the whole industry is evolving," said Nadav Malin, president of BuildingGreen, a consulting firm that publishes LEED user's guides. One key change to earn certification is a requirement that makes it necessary for building operators to provide a five-year energy and water efficiency plan, according to [this article](#).


PRODUCT NEWS

In somewhat of a surprise move, ASTM announced that their certification division will begin developing product category rules (PCRs) and certifying Environmental Product Declarations (EPDs). This activity will occur outside of the standards development process and the work going on in ASTM E60 Committee on Sustainability on these very topics. According to ASTM staff, the certification division will likely consider the work being done in standards development, but will operate independently. One might speculate that the slow process of standards development and the business potential likely factored into their decision. ~Tina



ASTM Launches a New Initiative to Address the Environmental Impacts of Products

ASTM International

ASTM International announces its [new initiative](#) as a Program Operator for Product Category Rules (PCRs) and Environmental Product Declarations (EPDs), which will provide the venue for developing PCRs and verifying EPDs. "The ASTM International program will provide scientifically based, quantifiable information about product parameters such as resource consumption and ozone depletion, which will give both businesses and consumers an understanding of a product's real impact on the environment," says Timothy Brooke, vice president of certification, training and proficiency testing at ASTM International. Through ASTM's certification program, technical advisory committees will oversee the development process for PCRs.

According to Amy Costello, environmental sustainability manager, Armstrong World Industries, and E60.13 chairman, Subcommittee E60.13 evolved out of a presentation on the nature of sustainable manufacturing given by representatives of the National Institute of Standards and Technology during the April 2012 E60 committee meeting. The purpose of the presentation was to discuss the need for sustainable manufacturing standards and E60's potential role in developing those standards. "As manufacturers embark on the journey of benchmarking and developing sustainability metrics, they will quickly realize that they are in uncharted territory," says Costello. "While there are many sources of information about sustainable manufacturing, few standards exist," according to [this announcement](#).
